## History of presenting illness

 Presenting A case of 60 yr old male patient came with a complain of protrusion of the right eye along with watering and discharge of the eye since 1 month which was acute and painfull in nature.patient consulted to private hospital where he has been diagnosed with hyperthyroidism as serum TSH was < 0.01 ml/L.,free T4 was 3.05 ng/dl and hence started on anti thyroid medication.

## Past history

 Patient had no any significant Past ocular / medical/surgical /drug /allergic/family history.

#### **General Examination**

- Patient had no signs of Anemia /jaundice/Cynosis /clubbing /pallor /lymphedenopathy
- Vitals were within normal limits


There was no any previous ocular surgery or ocular trauma Neither there were any other systemic illness.

## How we treated?

- Affected eye were padded with HPMC eye onitment twice a day
- Patient was treated with injection methyl prednisolone 500 mg BD intravenously for 3 days followed by oral steroids
- Injection vitamin B12 intramuscularly on alternate day
- Tablet Multivitamins
- Proptosis was reduced gradually following the treatment.
- Patient has been adviced for regular follow up after discharge
- Exophthalmos as well as the other symptoms like exposure keratitis were gradually reduced following treatment
